HOA Mobile App Proposal

Mobile based applications have captured user's attention in profound manner due to its simplicity and ease of use. Majority of users prefer to use mobile applications to find information and communicate to other parties without worrying about URL and/or ever changing contact details or email addresses of other parties. HOA is no exception to this change. Board members, review committee members and many other things in HOA admin shuffle on a periodic basis. Keeping track of these changes for a household/HOA member is not an easy task. But a mobile application along with other benefits can make this change transparent to household/members and help increase members' active participation in HOA activities.

The proposed application software bundle includes Android and iOS App for households in HOA and web based application for administrative purposes. Omnask uses agile development methodology to quickly respond to constantly changing customers' needs, to develop software applications as per the satisfaction of clients, and maintain/support the software long term.

Following features are included in the HOA mobile app:

- 1. Secure login through Phone number and OTP
- 2. Data stored in secured cloud
- 3. View HOA board members details
- 4. News and Updates (HOA admin can post messages which would be displayed in HOA mobile app)
 - a. The HOA app can access and view historical messages as well.
 - b. Messages can contain text, pdf files, and photos as needed.
- 5. Events (HOA admin can set up events which would be displayed in HOA mobile app)
 - a. Event messages can have event date, time, duration, text, zoom meeting link, pdf as well as photos as needed.
 - b. HOA admin can set up event reminders.
- 6. Inbox messages (HOA admin can communication one on one with HOA residents)
 - Households/members can reach out to HOA officials without knowing their private contact info.
 - b. Residents/HOA admin can view historical messages.
 - c. Messages can include text, pdf, photos as needed.
 - d. App notification display for new message arrival.
- 7. Reporting violations (resident to HOA admin)
 - a. Residents can send neighborhood violation(s) directly to HOA admin.
- 8. HOA Violation notification to individual resident
 - a. HOA admin can send violation notifications to residents directly.
 - b. Residents can respond to violation notifications through the HOA app.

- 9. Residents can view amenities available within the HOA community.
 - a. Clubhouse, pool, tennis courts, fitness centers.
 - b. Pictures, location, timing and descriptions can be updated by HOA admin.

Following features are included in the web HOA admin app:


- 1. Admin account

- 3. Manage household/members account for HOA mobile app
- 4. Send/Receive messages to/from individual resident members
- 5. Post HOA news and updates to all resident members
- 6. Create and post upcoming events
- 7. Manage amenities information
- 8. Upload HOA documents applicable to all residents
- 9. Manage Compliance
- 10. ARC communication








HOA Mobile APP Screens













HOA Management/Admin side WebApp Screens
